Honorable Members:

In an effort to improve operations at the Oneida County Board of Elections, I respectfully request that the Board take the following actions:

1. Create four (4) new Principal Clerk positions (two to be filled by each Commissioner);
2. Reallocate the title of Deputy Commissioner of Election from a Grade 29M to Grade 38M, Step 2, at a salary of \$60,851;
3. Appoint Sharie Fiorini-Parsons as Deputy Commissioner of Election at Grade 38M, Step 5, at a salary of \$67,168; and
4. Appoint Naysha LoMedico as Deputy Commissioner of Election at Grade 38M, Step 5, at a salary of \$67,168.

I request that these actions be placed on the Agenda for consideration at your next meeting.


