FLU SCHEDULE 2009

The fee for flu immunization is \$25 for adults (ages 19 and older) not covered by Medicare Part B or Medicaid. Those with Medicare Managed Care Plans who choose not to obtain vaccine from their primary care provider will be charged \$25.00 cash or check. Because the flu immunization differs, clinics for adults and children will be scheduled at different times.

Children's (ages 18 and younger) flu shots will be offered during regular immunization clinic hours in October. Please call 798-5747 for availability.
