





**RE: MEMORIALIZING PETITION CALLING UPON GOVERNOR PATERSON AND NEW YORK STATE LEGISLATURE TO OPPOSE BUDGET BILLS A.9713/S.6613 (INTERAGENCY TASK FORCE ELIMINATIONS) WHICH PROPOSES THE ELIMINATION OF THE FIRE SAFETY ADVISORY BOARD, THE ARSON BOARD AND THE FIRE FIGHTING AND CODE ENFORCEMENT STANDARDS AND EDUCATION COMMISSION FROM THE OFFICE OF FIRE PREVENTION AND CONTROL**

**WHEREAS,** Due to the New York State budget crisis, the Governor's 2010-2011 Executive Budget Proposal (via Budget Bills A.9713/S.6613 – Interagency Task Force Eliminations) proposes the elimination of Fire Safety Advisory Board, the Arson Board, the Fire Fighting and Code Enforcement Standards and Education Commission from the Office of Fire Prevention and Control, **and**

**WHEREAS,** The critical need for the Boards and Commission are obvious for the protection of the public and the Fire Service, **and**

**WHEREAS,** In an effort to negate the need to eliminate the Boards and Commission, the New York State Association of Fire Chiefs is recommending that Board and Commission members not be reimbursed for any expenses incurred in the performance of their duties, **and**

**RESOLVED,** That the Oneida County Board of Legislators calls upon Governor Paterson and locally elected State Legislators to oppose Budget Bills A.9713/S.6613 which will eliminate the Fire Safety Advisory Board, the Arson Board, the Fire Fighting and Code Enforcement Standards and Education Commission from the Office of Fire Prevention and Control, **and now therefore be it**





Attached for your review and approval is correspondence from Gerald Pedersen, Deputy Director of Emergency Services, requesting the creation of eight (8) new Public Safety Telecommunicator positions (Grade 21D, Step 2 \$27,042) in the Emergency Communications (911 Central Dispatch), Cost Center 3020.

As stated in Deputy Director Pedersen's letter, the eight (8) new Public Safety Telecommunicator positions are needed due to the increase staffing required to take over dispatching duties of the police and fire departments currently dispatched by the New Hartford Central Dispatch. The staffing required is to fill positions on a 24 hours/7 days a week rotation.

The New Hartford Town Board voted to abolish the Central Dispatch functions by the end of 2010. In order to provide the County 911 Center to provide the Emergency Communications and 911 assistance to the citizens of the Town of New Hartford personnel has to be in place and trained before the termination of the New Hartford Dispatch Center Operations.

These positions would be funded by county resources.

Other duties will be reviewing /updating procedures, filling in on shifts for other supervisors as needed, records management and other duties as required.

In order to provide the County 911 Center to provide the Emergency Communications and 911 assistance to the citizens of the Town of New Hartford, personnel has to be in place and trained before the termination of the New Hartford Dispatch Center Operations.

I am requesting the creation of one (1) supervisor position for the Emergency Services 911 center.

This position would be assigned to the 911 center due to the increased staffing required to take over dispatching duties of the police and fire departments currently dispatched by the New Hartford Central Dispatch. Our current staffing does not meet the requirements needed for the increased workload and responsibilities. This supervisor's primary responsibilities will be the creation of training plans, training of newly hired dispatchers and the continuing education and training of current dispatchers. Other duties will be reviewing/updating policies and procedures, filling in on shifts for other supervisors as needed, records management and other duties as required.

The New Hartford Town Board voted to abolish the Central Dispatch functions by the end of 2010. In order for the County 911 Center to provide the Emergency Communications and 911 assistance to the citizens of the Town of New Hartford personnel have to be in place and trained before the termination of the New Hartford Dispatch Center operations. Training of experienced personnel will take approximately three months; newly hired personnel with no experience could take up to five months to complete. A training program needs to be implemented now and with the strong possibility of the Utica PSAP merging in 2011 this position needs to be filled in 2010.

This position would be funded by county resources.
