Dear Mr. Fiorini:


On Friday, August 14, 2015, Governor Cuomo signed legislation extending the sunset date on the sales and compensating use taxes for Oneida to November 30, 2017. In order for the extension to be implemented, the Oneida County Board of Legislators must adopt a resolution adopting the extension authorized by the State. The action of the Board of Legislators is required by state statute and is time sensitive; being required by September 2, 2015.


Accordingly, I am requesting that you call for a Special Meeting of the Oneida County Board of Legislators to consider and adopt a resolution extending the additional rates of taxes on sales and compensating use of tangible personal property and certain services, on occupancy of hotel rooms and on amusements before September 2, 2015.
