PUBLIC HEALTH SANITARIAN

DISTINGUISHING FEATURES OF THE CLASS: The incumbent in this class performs professional activities which may include the investigation and inspection of the non-engineering aspects of environmental health control. The Public Health Sanitarian applies the principles of the physical, biological and social sciences for the detection, evaluation, control and management of those factors in the environment which influence health. The incumbent performs under the supervision of a higher level Public Health Sanitarian. Supervision is exercised over subordinate technical personnel. The incumbent performs related work as required.

TYPICAL WORK ACTIVITIES: (Illustrative Only)

Inspects food service establishments, private water supplies, private disposal systems, bathing beaches and swimming pools, facilities for refuse disposal, x-ray installations, temporary and/or permanent residences and farm labor camps, mobile home parks;

Conducts lead poisoning and nuisance investigations;

Conducts air pollution studies and soil percolation tests;

Assists in investigations of outbreaks of diseases;

Collects water, milk, food and other samples for laboratory examination;

Investigates environmental nuisances;

Prepares reports on inspections and investigations;

Interprets laboratory reports;

Supervises and trains subordinate personnel;

May testify at enforcement proceedings.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS: Good knowledge of environmental health principles, practices and inspection methods; ability to plan and supervise the work of technical employees; ability to prepare and deliver effective talks and secure the interest and cooperation of civic groups and officials; ability to train others in environmental health work; ability to develop good public relations; good professional judgment.

MINIMUM QUALIFICATIONS: Either:

- (A) Graduation from a regionally accredited or New York State registered four-year college or university with a Bachelor's Degree, including thirty (30) credit hours in the physical and biological sciences*, of which not more than twelve (12) credit hours may be in the applied sciences; **OR**
- (B) Graduation from high school or possession of a high school equivalency diploma **AND** five (5) years of experience as a public health technician deemed satisfactory by the local commissioner of health or public health director.

*The Physical and Biological Sciences include courses such as biology, microbiology, botany, zoology, general inorganic chemistry, qualitative and quantitative analyses, biochemistry, organic chemistry, geology and physics.

NOTE: Appointees must satisfactorily complete a public health training course approved by the State Health Department within one year of appointment.

SPECIAL REQUIREMENT: Possession of a valid New York State driver's license at time of application. License must remain valid throughout appointment in order to meet the transportation requirements of the job.
