A refund will be made in the amount of One Hundred Dollars (\$100.00), to bidder(s) or Fifty Dollars (\$50.00) to Non-Bidders, for the return of all of the sets in good condition within thirty (30) days of award or rejection of Bids.

Bids must be submitted upon the proposal form(s) furnished, and must not be detached from the proposal booklet. A deposit in the amount of 5% of the bid will be required. This deposit shall consist of a bid bond or certified check payable to the COUNTY OF ONEIDA. Failure to submit a bid bond or certified check with bid will result in automatic disqualification of bid. Failure to submit a bid upon the proposal form(s) furnished by the Oneida County Department of Public Works or submittal of form(s) detached from the proposal booklet will result in automatic disqualification of bid.

A Pre-Bid Meeting will be held at **10:30 AM on Wednesday, December 14, 2016**. The meeting will be in the 1st Floor Conference Room at the George E. Carle Complex, 6000 Airport Road, Oriskany, NY 13424.

A Performance Bond will be required and for an amount not less than 100% of bid price.
