Sealed Bids, subject to the conditions contained herein, will be received by the ONEIDA COUNTY DEPARTMENT OF PURCHASING until **10:30 AM** local time (Official Dymo Time Stamp) on **September 20, 2017**, and then publically opened and read, for furnishing all labor and materials and performing all work for:

Specifications and plans must be obtained from the Oneida County Department of Purchasing (6<sup>th</sup> floor), 800 Park Avenue, Utica, NY 13501. A deposit of One Hundred Dollars (\$100.00) will be required for each set. Checks must be received under separate cover. Bidders shall be responsible for all shipping fees. Cash deposits will not be accepted. Also required is Federal ID # or Social Security # at time of purchase. All deposit checks are to be made payable to the COUNTY OF ONEIDA. A refund will be made in the amount of One Hundred Dollars (\$100.00), to bidder(s) or Fifty Dollars (\$50.00) to Non-Bidders, for the return of all of the sets in good condition within thirty (30) days of award or rejection of Bids.

Bids must be submitted upon the proposal form(s) furnished, and must not be detached from the proposal book. A deposit in the amount of 5% of the bid will be required. This deposit shall consist of a bid bond or certified check payable to the COUNTY OF ONEIDA. Failure to submit a bid bond or certified check with bid will result in automatic disqualification of bid. Failure to submit a bid upon the proposal form(s) furnished by the Oneida County Department of Public Works or submittal of form(s) detached from the proposal book will result in automatic disqualification of bid.

A Performance Bond and Labor and Materials Payment Bond will be required for an amount not less than 100% of bid price.

Packages containing bids must be sealed, marked, and addressed to Oneida County Department of Purchasing (6<sup>th</sup> floor), 800 Park Avenue, Utica, NY 13501. Also mark on envelope or package, the bid reference number and the project title for which the proposal is submitted.
