Checks must be received under separate cover (if electronic bidding) prior to bid opening, do not include check inside of bid. Bidders shall be responsible for all shipping fees. Cash deposits will not be accepted. Also required is Federal ID# or Social Security # at time of purchase. All deposit checks are to be made payable to the COUNTY OF ONEIDA. A refund will be made in the amount of One Hundred Dollars (\$100.00), to bidder(s) or Fifty Dollars (\$50.00) to Non-Bidders, for the return of all of the sets in good condition within thirty (30) days of award or rejection of Bids.

Bids must be submitted upon the proposal form(s) furnished, and must not be detached from the proposal book. A deposit in the amount of 5% of the bid will be required. This deposit shall consist of a bid bond or certified check payable to the COUNTY OF ONEIDA. Failure to submit a bid bond or certified check with bid will result in automatic disqualification of bid. Failure to submit a bid upon the proposal form(s) furnished by the Oneida County Department of Public Works or submittal of form(s) detached from the proposal book will result in automatic disqualification of bid.

A Performance Bond will be required and for an amount not less than 100% of bid price.
