Sealed Bids, subject to the conditions contained herein will be received by the **DEPARTMENT OF AVIATION** at the Griffiss International Airport (RME) 660 Hangar Rd. Suite #223, Rome, NY 13441 until **1:30 PM local time on August 10, 2017** then publicly opened and read aloud for furnishing all labor and materials and performing all work for:

The proposed project generally consists of office build-out of approximately 3,300 sf within existing hangar. Build-out to generally consist of office space, conference and storage space within the existing nose dock #786. The work scopes consist of one prime contract involving General, Electrical, and Mechanical Construction improvements.

Specifications and drawings must be obtained from the Oneida County Purchasing Office, 6th Floor, 800, Park Ave., Utica, NY 13501. A deposit of One Hundred Dollars (\$100.00) will be required for each set Cash deposits will not be accepted. Also required is Federal ID Number or Social Security Number at time of purchase. All deposit checks are to be made payable to the COUNTY OF ONEIDA. A refund will be made, in the amount of One Hundred Dollars (\$100.00), to Bidder(s) or Fifty Dollars (\$50.00) to Non-Bidders, for the return of all the sets in good condition within thirty (30) days of award or rejection of Bids.

Bids must be submitted upon the proposal form(s) furnished, and must not be detached from the proposal book. A deposit in the amount of 5% of the bid (including base bid, allowance and add on items) will be required. This deposit shall consist of a bid bond or certified check payable to the COUNTY OF ONEIDA. Failure to submit a bid bond or certified check with bid will result in automatic disqualification of bid. Failure to submit a bid upon the proposal form(s) in the proposal book furnished by the Oneida County Department of Aviation will result in automatic disqualification of bid.

Performance and Material & Labor payment bonds will be required for an amount not less than 100% of bid price. Packages containing bids must be sealed marked and addressed to the Director of Purchasing, Griffiss International Airport, 660 Hangar Road, Suite #223, Rome, NY 13441. Also mark on the envelope or package the Bid Reference Number and type of work for which the proposal is submitted.

A pre-bid meeting to review the specific requirements of the contract, and conduct a site visit is scheduled for July 28, 2017, at 11:00 a.m. at the Griffiss International Airport, Dept. of Aviation Office, located at 660 Hangar Road, Suite #223, Rome, NY 13441. All prospective bidders are encouraged to attend.
