A deposit of One Hundred Dollars (\$100.00) will be required for each set. Bidders shall be responsible for all shipping fees. Cash deposits will not be accepted. Also required is Federal ID# or Social Security # at time of purchase. All deposit checks are to be made payable to the COUNTY OF ONEIDA. A refund will be made in the amount of One Hundred Dollars (\$100.00), to bidder(s) or Fifty Dollars (\$50.00) to Non-Bidders, for the return of all of the sets in good condition within thirty (30) days of award or rejection of Bids.

Bids must be submitted upon the proposal form(s) furnished, and must not be detached from the proposal booklet. A deposit in the amount of 5% of the bid will be required. This deposit shall consist of a bid bond or certified check payable to the COUNTY OF ONEIDA. Failure to submit a bid bond or certified check with bid will result in automatic disqualification of bid. Failure to submit a bid upon the proposal form(s) furnished by the Oneida County Department of Public Works or submittal of form(s) detached from the proposal booklet will result in automatic disqualification of bid.

A Pre-Bid Meeting will be held on the 10th floor of the Oneida County Office Building, 800 Park Avenue, Utica, NY 13501 at **10:30 AM on Thursday, January 24, 2019**. The Design Architect and Oneida County Engineer will be on site to discuss the scope of work and bid documents.

A Performance Bond will be required and for an amount not less than 100% of bid price.

Packages containing bids must be sealed, marked, and addressed to **Oneida County Department of Purchasing, (6th floor) 800 Park Ave, Utica, NY 13501**. Also, mark on the envelope or package, the bid reference number and the type of work for which the proposal is submitted.
