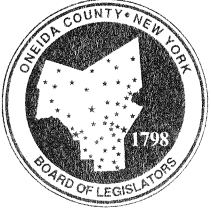

Honorable Members,

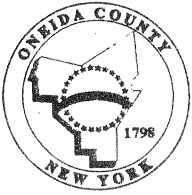
I have received the attached request from County Executive Picente and Sheriff Maciol to create two new positions for the Child Advocacy Center.

I am hereby requesting the creation of two new positions of Deputy Sheriff Patrol to the Oneida County Sheriff's Office, to be assigned as Investigators for the Oneida County Child Advocacy Center on a full time basis at Grade S02.

The Oneida County Child Advocacy Center serves the critical role of investigating child sexual abuse cases in which the victim is under 17 years of age. The Center initiates approximately 500 investigations each year, and is understaffed for this quantity of investigations. The addition of the two positions will allow the Center to more effectively pursue these investigations and gather the best evidence possible. It will also provide needed stability to this essential intergovernmental collaboration.

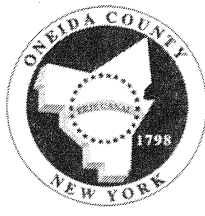
I have discussed this matter with both Oneida County District Attorney Scott D. McNamara and Oneida County Sheriff Robert M. Maciol and they both join me in this request.


Dear County Executive Picente:

Dear Commissioner Talerico:

As a results of an increase in the reporting of sexual abuse offenses against the children of Oneida County, and the Oneida County Child Advocacy Center now being managed by the Sheriff's Office we have found the need to create two new deputy positions.

In the past year, we have found an increase in the case load since the inception of the Oneida County Child Advocacy Center and that there is a need for more deputies to be involved in the crucial role of investigating sexual abuse cases against the children of Oneida County. We are investigating approximately 500 cases per year with the same compliment of staff since the CAC was created.

In the interest of effectively protecting the victimized children of sexual abuse in Oneida County, we have a need for additional deputy positions to effectively manage the increased case load of the Child Advocacy Center.

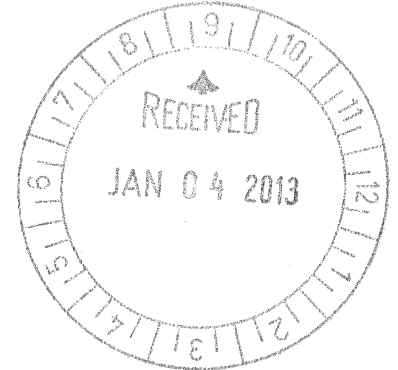

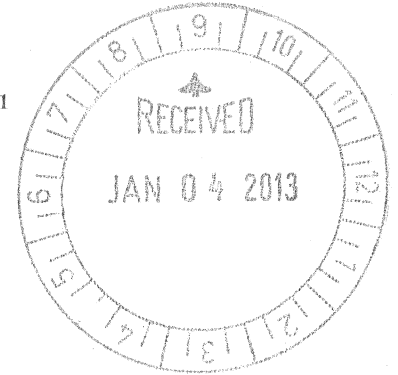

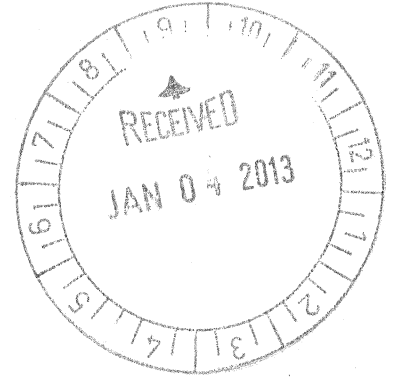
