I am in receipt of correspondence from Budget Director Tom Keeler requesting the creation of a position Assistant Public Defender III Grade 36 P at \$46,572 in cost center A1173 Public Defender Civil Division.

The original request for this position was submitted as a 2014 budget request, however because the NYS Office of Indigent Legal Services Grant had not yet been approved the request was removed from the proposed 2014 budget. Since that time the Grant has been approved and fully funds the new position. Public Defender Furno will eliminate a Part Time Public Defender position in his office as part of this request.

Grant funded positions for the Public Defender Criminal Division have already been created under separate legislation.

Oneida County has been notified it has been successful in receiving an award from the NYS Office of Indigent Legal Services (OILS). This grant will be used to support improved quality of representation and services of the indigent population of Oneida County.

The Board already approved new positions in the Public Defendant's – Criminal Division at their December 11, 2013 meeting. This legislation should have also included legislation to request a new attorney position in the Public Defender – Civil Division.

As a result we need legislation to establish an attorney position in the Public Defender — Civil Division, cost center A1173, Assistant Public Defender III, Grade 36P Step 1 at \$46,572. This position is fully reimbursed by the above mentioned grant. The Public Defender — Civil Division will eliminate one part-time position with the creation of this full-time position.
