We recommend full Board consideration of the attached bids for approval on the March 11, 2020 meeting and respectfully request that you forward same at your earliest opportunity.



Honorable Members:

There is a need for additional funds in various salary and related personal services' accounts throughout the County for 2019. These transfer requirements have resulted from a variety of factors such as the settlement of several labor contracts, which resulted in the payment of retroactive wages to the employees covered by those agreements and the payment of overtime for special projects that may arise. The resulting payroll adjustments, as expected, caused budgetary shortages in many salary accounts, all of which are adequately covered by surpluses in other personal services' accounts.

Due to the need to close the 2019 accounting records, I ask that these transfers be acted upon at the **March 11th meeting**. I therefore request your Board approval for the following **2019** fund transfers:


