WHEREAS, This Board is in receipt of correspondence from Oneida County Executive, Anthony J. Picente, Jr., requesting an extension of time to submit the 2021 Capital Budget and Six Year Capital Program as outlined in Article VI, Section 603, of the Oneida County Charter, due to the COVID-19 pandemic, and

WHEREAS, Article VI, Section 603, of the Oneida County Charter states that the County Executive shall submit the proposed Capital Budget and Six Year Capital Program by October 5th of each year. The County Executive is requesting an extension of time to submit the proposed 2021 Capital Budget and Six Year Capital Program to November 12, 2020, and

WHEREAS, Changing the submission date of the proposed 2021 Capital Budget and Six Year Capital Program will necessitate the rescheduling of the Oneida County Board of Legislators Meeting currently scheduled to be held on November 25, 2020, and

WHEREAS, In accordance with Oneida County Charter Article II, Section 202, said changes must be approved by the Oneida County Board of Legislators, now, therefore, be it hereby

RESOLVED, That the Oneida County Board of Legislators hereby approve the extension of time for Oneida County Executive, Anthony J. Picente, Jr., to submit the proposed 2021 Capital Budget and Six Year Capital Program to November 12, 2020, and it is further

RESOLVED, That the Oneida County Board of Legislators Meeting previously scheduled for November 25, 2020 is hereby rescheduled to December 2, 2020.
