This award is for the three-year distribution of funds for program support. 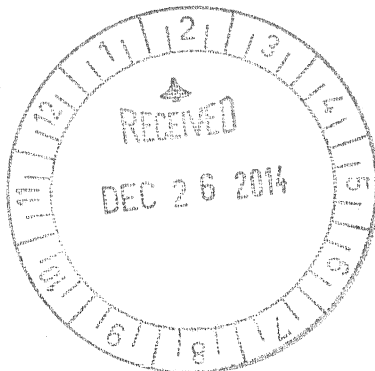



The Oneida County Public Defenders Office Criminal Division has been awarded distribution # 4 from the New York State Office of Indigent Legal Services for several initiatives. The Public Defenders Office will be adding a new attorney to handle the increased workload under the new initiatives being undertaken by the New York State Office of Indigent Legal Services. This grant is for \$538,146 and will be paid over the next three years.

A portion of the grant will be used to help streamline the payment process for the attorney's used in conflict situations. This workload has increased over the last several years and has become quite cumbersome. These costs will be covered under the grant and it is the goal to make a model which can be used by other counties in New York State.



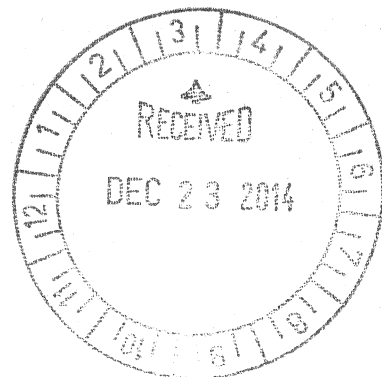


I am requesting approval of a 5-year contract with the New York State Unified Court System for security services that our office provided and will continue to provide the courts for the period April 1, 2014 through March 31, 2019. This contract consists of five, one-year period agreements, commencing on April 1st and terminating on March 31st in each successive year of the contract. **This Contract requires approval by the Board of Legislators at its next meeting.**

The enclosed pertains to the current one-year period agreement, which encompasses security services we provided from April 2014 and will provide through the end of March 2015. The Unified Court System will not reimburse us for our security services, an amount totaling \$2,110,000.00, until an executed, renewed contract is in place; therefore, **it is imperative that this contract gains swift approval.**

There are a total of four contracts included in this packet, as the Unified Court System requires two, fully executed copies (our office and the Law Department receive the other two copies).



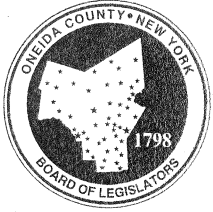

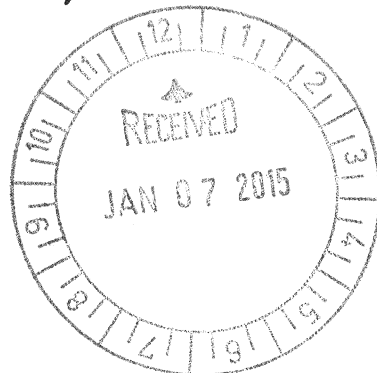
