Dear County Executive Picente,

Oneida County currently procures electric utility service from Constellation NewEnergy, Inc. through a public bid conducted by Genesee County and managed by the Municipal Gas and Electric Alliance (MEGA Contract). MEGA serves more than 300 municipalities and private business in upstate New York, and through aggregated utility procurement, via competitive bid, offers very competitive pricing. Current contracts expire in November 2020.

The Department of Public Works has performed an evaluation of alternative procurement methods and utilization of the MEGA Contract appears to be the most cost competitive and efficient option that complies with New York State General Municipal Law. To the best of our knowledge there are no other aggregated procurement programs available for use by Oneida County at this time. Due to the complexities, unique nature, and regulations associated with the electric utility market, conducting an independent bid would require the services of a professional consultant. Consulting services would add potentially significant cost and to the best of our knowledge bid results are likely to be similar to, or greater than, pricing established in the MEGA Contract.

Fixed firm rates versus variable rates were evaluated. Due to exceptionally low fixed firm rates (perhaps record low rates) the difference is nominal. In addition, the need for stable and predictable expenditures is now more important than ever. Therefore, at this time I recommend taking advantage of the exceptionally low fixed firm rates.

I recommend approval and execution of the enclosed contracts with Constellation NewEnergy, Inc. for Oneida County's electric utility service. The combined annual cost would be approximately \$1,200,000.00. If you agree and the enclosed contracts are acceptable then please forward same to the Oneida County Board of Legislators for consideration. Thank you for your continued support.

Dear County Executive Picente,

Executive orders issued by the Governor of New York State associated with COVID-19 have resulted in significant changes to Oneida County's standard operating procedures. Compliance with the social distancing requirements of the orders was not possible solely utilizing existing facilities and office space. Approximately 140 County employees have been temporarily relocated to Griffiss to achieve minimum social distancing requirements. For many reasons, a long-term solution at an alternative location is required immediately. The only cost effective and timely option is leased office space.

On July 9, 2020, the Department of Public Works solicited proposals for approximately 35,000 square feet of office space located in the vicinity of Rome or Utica. Three proposals were received for the following locations:

6 Rhoads Drive, Utica, NY 1877 Black River Boulevard, Rome, NY 501 Bleecker Street, Utica, NY

It was determined that 501 Bleecker Street is the most cost competitive and operationally efficient location. Space requirements and the final lease rate were negotiated and I recommend approval of the enclosed lease agreement. The agreement stipulates a five (5) year term, with three possible five (5) year renewal options. The annual lease rate for the first five-year term would be \$307,043.64 plus electric and gas utilities. A specified termination fee would be owed by the County if the first renewal option is not exercised, to reimburse the landlord's unrecovered expenses.

If the enclosed lease agreement is acceptable, then please forward to the Oneida County Board of Legislators for approval. Thank you for your continued support.

CONTRACT ADMINISTRATOR I

DISTINGUISHING FEATURES OF THE CLASS: This is a professional and administrative position involving the responsibility for planning, organizing, developing, monitoring, and analyzing grant programs and contract procedures in various program areas. The work includes compiling and interpreting various forms of data in preparing grant and program plan formulation. The incumbent works under the general supervision of a higher-level administrator. Supervision may be exercised over the work of paraprofessional and clerical assistants. The incumbent performs related work as required.

TYPICAL WORK ACTIVITIES: (Illustrative Only)

Plans, negotiates and develops contracts in collaboration with other program and fiscal personnel;

Collects, compiles and interprets program and financial data;

Coordinates requests for proposals and requests for provider interest for the provision of services in accordance with Federal, State, and Oneida County procurement requirements;

Oversees the electronic contract manager tracking database;

Establishes contact and maintains liaison with service provider agencies;

Prepares narrative reports and records as necessary for compliance with Federal, State and local regulations and standards;

Reviews and approves monthly vouchers submitted by contractors for accuracy, completeness and adherence to contractual compliance;
