Re: Utica City School District/IRT Program (2023-2024)

Dear County Executive Picente:

Enclosed is an agreement with the Utica City School District wherein the Oneida County Probation Department provides one part-time Probation Officer to the school district. This officer provides Initial Response Team (IRT) services and other supportive efforts in the school buildings. This successful partnership is designed to identify students with attendance and behavior problems, work with them and their families, and coordinate service delivery. In turn, many students are diverted from more formal persons in need of supervision and juvenile delinquent proceedings. The term of this agreement is from September 1, 2023 through June 30, 2024. Utica City School District will pay the County \$14,500.00 for these services.

If this agreement meets with your approval, please forward it to the Board of Legislators for further approval. I further request that this proposed agreement be approved as a template for use with other school districts, with the understanding that "district-specific terms" and some non-material terms will change from district to district. Your support of this program continues to be most appreciated. If you have any questions, please do not hesitate to contact me.

It is an early intervention strategy where students starting to display attendance and behavior problems are involved in a process wherein the Probation Department works with students, parents, school authorities, and service providers to effect positive outcomes and improvement.

2) <u>Program/Service Objectives and Outcomes:</u> This program is designed to reach students and improve attendance and behavioral problems without formal Court intervention.

3) <u>Program Design and Staffing:</u> One part-time Probation Officer is stationed in the Utica City School District.
