LOCAL LAW NO. ____ OF 2021

A LOCAL LAW SUPERSEDING COUNTY LAW §215 REGARDING THE LEASING OF PROPERTY OWNED BY THE COUNTY OF ONEIDA

BE IT ENACTED BY THE BOARD OF COUNTY LEGISLATORS OF THE COUNTY OF ONEIDA, STATE OF NEW YORK, AS FOLLOWS:

SECTION I. PURPOSE AND INTENT

The Oneida County Legislature hereby finds that it is in the best interests of this government and the residents of the County of Oneida to promote the highest and best use of all County-owned properties which are not currently needed exclusively for governmental purposes, and to provide for a mechanism whereby the County can raise additional revenues, and/or to provide a public benefit, from the lease of said parcels on the open market in a responsive manner for various terms, including terms exceeding five (5) years.

Additionally, this Local Law will make County property more attractive to developers looking to make long-term infrastructure investments in parcels they are leasing, such as for solar and wind production. This will in turn generate additional revenue for the County, and open up greater options for the leasing of County-owned land. By switching from an open, competitive bidding process to a request for proposals process, the County will have more flexibility in making leasing decisions, to ensure the County receives the best value possible for its property.

It is the intent of the County to supersede the provisions of County Law § 215 to the extent that it is inconsistent herewith.

SECTION II. APPLICABILITY

- A. Upon a determination that the real property is no longer needed for public use, the County of Oneida is hereby authorized, notwithstanding Section 215(4) of the County Law of the State of New York, which is hereby superseded, to enter into a lease of County-owned real property for a for a term not to exceed twenty-five (25) years.
- B. Leases of County-owned real property that are subject to the provisions of County Law Section 215 may be let through an advertised Request for Proposals process, in conformance with the County Procurement Policy and applicable law. The provisions of Section 215 of the County Law of the State of New York requiring letting to the highest responsible bidder are hereby superseded.

SECTION III. SEVERABILITY

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

SECTION IV. EFFECTIVE DATE

Notice of the adoption of this Local Law subject to permissive referendum shall be published in the official newspapers of record for the County.

This Local Law shall take effect at the end of the permissive referendum period upon filing in the Office of the Secretary of State, and if a permissive referendum is held, upon approval at the permissive referendum upon filing in the Office of the Secretary of State.
