RE: RESOLUTION ENCOURAGING NEW YORK STATE TO RECONSIDER AND AMEND BAIL REFORM AND DISCOVERY LAWS

WHEREAS Criminal justice reforms, which ended cash bail requirements for New Yorkers facing misdemeanor and non-violent felony offenses, were included in last year's budget and went into effect on Jan. 1, and

MARCH MEETING Held on Wednesday, March 11, 2020 at 2:00 P.M.

WHEREAS, the new discovery reform law passed with the 2019-20 state budget overhauled the discovery process, requiring an expedited timeline to provide materials such as police reports, radio transmissions, body-worn and dash-cam video, along with other data related to prosecution in 15 days; and

WHEREAS, There's a growing number of stories about criminals being arrested, being released the same day, and committing more crimes shortly thereafter, and

WHEREAS, Law enforcement and prosecution personnel are finding it hard to comply with the requirements of the new procedures because of the increased workload, not to mention the expense, and

WHEREAS, Current law rightfully protects law enforcement personnel from disclosure of name and adequate contact information in this process to protect them and their families from threats, the same protection is not extended to first responders who many times provide important services at crime scenes; and

WHEREAS, Ambulance service personnel, advanced life support first response services, certified first responders, firefighters, emergency medical technicians, or advanced EMTs, who are employed by or enrolled members of any service, should also have their personal identifying information protected from discovery so they aren't subject to retaliation or witness tampering; and WHEREAS, First responders are not on the scene to arrest people; they respond to emergency situations, but now because they may be witnesses to a crime their names and addresses are required to be turned over to the defense as part of the Bail Reform and Discovery Law; and

WHEREAS, Emergency personnel should have the same privacy protection as law enforcement officials, so they are not subject to retaliation or witness tampering; and

WHEREAS, These and other consequences have to be adjusted, and

RESOLVED, It is the hope of the Oneida Board of Legislators that state leaders will listen to the concerns of judges, district attorneys, law enforcement professionals, first responders and others to make appropriate changes to these criminal justice reforms during the current session of the New York State Legislature to ensure the criminal justice system works for all of New York's citizens.
