NYSDOT Region 2 Update

Deb Windecker gave a report to the committee detailing the transpired work of the NYSDOT Region 2.

\$48 million dollars in projects are to be let by the end of March. These projects mainly consist of general maintenance to preserve existing facilities. One of the bridge painting projects is, PIN 280622, for two bridges in Herkimer County. The first bridge is the NYS Route 51 Bridge that just underwent a \$4.5 million rehabilitation over the past two years. The second bridge is the North Washington Street Bridge in Herkimer.

PIN - 280623, a bridge rehabilitation project in Oneida County for eight bridges all along NYS Route 8 was recently let. The apparent low bidder for that project was Slate Hill. The last project being let in the SFY is the last of the 2016 BRIDGE NY projects. This bridge was delayed due to the flooding and the long term mitigation of waterways in the region. The project was let for \$2.25 million and the apparent low bidder was Gibonski. The project will start in the spring.

Investments of projects by NYSDOT was \$42 million with \$6.2 million for local projects. Harsh winter paving projects were recently let. BRIDGE NY has brought about substantial increases in funding for projects throughout the region.

75% of the investments made by NYSDOT to local projects goes towards bridges. On the state system, 38% of investments went to preventative maintenance of the infrastructure, primarily pavement. 26%, to bridges. 18%, to bicycle and walking facilities. \$4.4 million has been dedicated to the Bagg's Square Pedestrian Way project in Utica.

Extreme weather pavement funding in the amount of \$7 million was received by the regional office. Herkimer County received \$1 million to pave NYS Route 51 from the hamlet of Cedarville for nine miles worth of paving. Oneida County received \$1.2 million to resurface 11 lane miles from Route 412, to Route 233 in the Town of Kirkland.

\$11.9 billion capital program for transportation being proposed by Governor Cuomo for the upcoming SFY. BRIDGE NY and PAVE NY will be renewed for \$100 million each for the next two years. Furthermore, \$678 million will be proposed for the CHIPS program.

In the next SFY, a robust program of \$78 million dollars will be made for the region. \$14 million of that funding will go towards the Route 8 Bridge Replacement over Route 5 which will be funded through the freight program.

A groundbreaking ceremony for the Bagg's Square Pedestrian Way will be held on February 28 at 2:30 pm in the lobby of Union Station by the NYSDOT Commissioner, Marie Therese Dominguez. A 10 ft. shared use path will be constructed on the western bridge of the North Genesee Street Bridge. The estimated completion date of the project will be at the end of the year, roughly coinciding with the completion of the 5s Safety Project.

Review of Bylaws

Dana introduces that the bylaws will be analyzed and possible revisions to them will be recommended at the next meeting of the GP&L. Additionally, a review of the membership of the committee was made by Vincent Bono after the December 2019 GP&L meeting. His request will be incorporated with a review of the operating bylaws for the MPO. Both of these actions stem from the low attendance of the GP&L membership within the past two years. Preliminary work into the matter has come up with ideas to enhance the efficiency of operations for the HOCTS MPO and conceptual ideas to be discussed include reducing the size of the membership, altering the membership ratio to more accurately reflect the population, and modernizing the language of the bylaws to

allow flexibility in convening a quorum, and to bring the procedures of the committee to be in alignment with the other 13 MPOs across New York State.
