# Director's Report

- Dana Crisino gave the following report on behalf of the Herkimer Oneida Counties Transportation Council:
  - Transportation Improvement Plan
    - The MPO has been developing the next four-year capital program Transportation Improvement Plan (TIP) in conjunction with NYSDOT Region 2 for FFY 2023 2027. HOCTC put out a call for projects from member municipalities and partner agencies and incorporate those into an illustrative list of projects. The draft will be released for public review in early August and the committee will receive notification. Action will be taken at the September 2022 meeting on the plan after a presentation with NYSDOT.
  - Transportation Program Manager
    - The MPO has been able to hire a Transportation Program Manager to assist in the operations. They will be joining the organization at the end of July, and they have previous experience in running an MPO.
  - Summary of the IIJA
    - A new 5-year surface transportation bill was recently passed by the Federal government funded at \$1.2 trillion.
    - New formula/guaranteed highway grant programs include: bridge investment program (\$12.5 billion), congestion relief (\$250 million), charging and fueling (\$2.5 billion), rural surface transportation program (\$2 billion), PROTECT/Resiliency (\$7.3 billion), Reduce Truck Emissions at Ports (\$400 million), National Infrastructure Project Assistance (\$5 billion), Safe Streets Program (\$5 billion), Strengthening Mobility and Revolutionizing Transportation Program (\$500 million), Wildlife Crossing Pilot (\$50 million), Reconnecting Communities Pilot (\$1 billion), Prioritization Pilot (\$50 million).
    - New competitive grant programs: National Infrastructure Project Assistance (\$5 billion), Bridge Investment Grants (\$5 billion), Grants for Charging and Fueling Infrastructure (\$2.5 billion), Rural Surface Transportation (\$2 billion), Congestion Relief (\$250 million), Healthy Streets (\$500 million), National Infrastructure Project Assistance (\$5 billion), Safe Streets for All (\$5 billion), SMART program (\$500 million), Truck Emissions at Ports (\$400 million), National Culvert Removal, Replacement, Restoration (\$1 billion), Promoting Resilient Operations for Transformative Efficient Cost-Saving Transportation (PROTECT) (\$1.4 billion), Reconnecting Communities (\$1 billion).
  - Safe Streets for All (SS4A)
    - One of the new competitive grant programs is SS4A. The program supports planning, infrastructure, behavioral, and operation initiatives to

prevent death and serious injuries on roads and streets for all roadway users. The program is funded at \$5 billion for five years and is open to MPOs, cities, counties, and towns with applications due September 15. There are two types of grants available: Action Plan (\$200,000 to \$1,000,000) and Implementation (\$3,000,000 to \$30,000,000) funded at an 80% federal and 20% local match (in-kind services or cash) split. An Action Plan grant will show where unsafe conditions exist in the transportation network, show where underserved communities exist, and how to make these unsafe and underserved areas safer. An Implementation Grant funds the solutions outlined in the Action Plan. The MPO, Oneida County, and Herkimer County are eligible to apply. Actions that are advised to be taken to apply include: adoption of a complete streets policy to make application competitive and ensuring that the local match of funding is available (\$40,000 minimum and \$200,000 maximum). The MPO will have discussions with both counties to gauge interest in applying. A resolution authorizing the application will need to be made at the next quarterly meeting if interested as well as supporting resolutions from each county.

# • NYSDOT Region 2 Report

- Mark DeRocco gave a report on the activities that NYSDOT Region 2 has performed in the last quarter
- A new five-year capital plan for New York State has been approved funded at \$32.8 billion for SFY 22-23 through SFY 26-27. This represents a 40% increase over the previous five-year capital plan. Building the TIP/STIP is a part of this plan and will be approved in September. BRIDGE NY will be funded \$1 billion over five years, this will increase \$100 million annually to \$200 million annually. NYSDOT is exploring options to award additional funding. Breakdown of the funding includes: \$538 million for CHIPS, \$150 million for Pave NY, \$100 million for Extreme Weather Recovery (EWR), \$100 million for State Touring Route Road Revitalization (new for 2021), and a new \$100 million for Operation Pave our Potholes.
- The Bipartisan Infrastructure Law authorized a Bridge Investment Program funded at \$2.36 billion in planning funds. Minimum award of up to 90% for off-system bridges with a maximum of \$100 million. States, MPO's, county, local, and tribal governments are eligible. The purpose is to improve the safety, efficiency, and reliability of the movement of people and freight by replacing, rehabilitation, preserving, and protecting bridges in the National Bridge Inventory (NBI). Additionally, improving the conditions of bridges in poor condition and support bridges in fair condition from dropping to poor condition. There is a deadline of September 8 to apply.
- O NYSDOT Region 2 applied for two grants for the North Genesee Street Multi-Modal Connector and Bridge Replacement project: RAISE (Rebuilding American Infrastructure with Sustainability and Equity) for \$18 million and Multi-Discretionary Grant for \$25 million. NYSDOT expects to hear back in the Fall for award announcements.

- Route 26/365 Safety and Pavement Project in the City of Rome for \$6.7 million –
   Hanson
- o Route 8 over 5 & 12 Bridge Replacement is expected to be completed in Fall 2022. Three ramps will be closed from April through August.

  - Middle Settlement Road in the Town of New Hartford for \$4 million CCI Contractor
  - Oneida Street over Sauquoit Creek in the Town of New Hartford for \$1.0 million –
     DH Smith Contractor
  - Mohawk River Trail, Phase 2 in City of Rome for \$1.0 million.

  - West Main Street over Moyer Creek in the Village of Frankfort as a BNY 2018 awardee for \$4.5 million

#### o Administrative Modifications to the 2020 – 2024 TIP

- Dana gave a report of the administrative modifications made to the MPO TIP in the last quarter as the following:
  - 2022 04MOD, PIN 280639, Culvert Repair and Replacement Project 22. ROW Acquisitions and ROW Incidentals will increase project cost by \$35,000.
  - 2022 05MOD, PIN 265057, 2018 TAP Rome Wheels to Heels Streetscapes. Funding year for Construction and Construction Inspection changed from 2022 to 2023.
  - 2022 06MOD, PIN 213457, Route 5 French Road Interchange Bridge Repairs. Construction costs increased by \$336,000 to \$3,905,000.

## • Other Business

- John Piseck asks Anthony Picente about the NYS Canal Corporation and chargers along the canal. Anthony replies that there is a meeting coming up at the end of July where this will be discussed, and he will report back to the committee.
- O John Piseck mentions that he and other representatives have met with Centro regarding a study to have transit service in Herkimer County, specifically, to the Schuyler Business Park and Utica. Dana replies that a possible transit service into Herkimer County had been analyzed by HOCTC's consultant, Transpo, in the System Wide Analysis for Transit Based Connections.
- O A discussion is had between Jerrin George and the committee regarding new exits on the Thruway, specifically in Herkimer County. Jerrin states that the Thruway main office would have to be involved to undertake a study to explore the possibility of opening new exits. Exit 31 is also mentioned and how HOCTC will be undertaking a study analyzing the interchange. The scope of the study is currently in development. Anthony Picente asks if discussion can take place at the next meeting regarding Exit 31 and a new exit in the vicinity of Schuyler with additional people representing the Thruway.
