- Discussion: Dana Crisino, HOCTC Director, noted that the New York State Thruway Authority (NYSTA) sent in a revision to the December 14, 2023 GP&L Meeting Minutes.
 - Please strike the following information from the December 14, 2023, HOCTC Governmental Policy and Liaison Committee minutes found under the New York State Thruway Authority Report: A question was asked about speeding cameras that can result in ticketing being installed on the Thruway, not in construction areas. NYSTA confirmed that there have been permanent speeding cameras installed on I-90 from Buffalo to Rochester and near Exit 29A but there are none from Little Falls to Syracuse, with nothing scheduled at this time. The exact locations can be found online.
 - From NYSTA: We apologize but the information provided was wrong and does not accurately represent operations on the Thruway. The Thruway Authority uses speed cameras for speed enforcement only as authorized by law. The law specifically permits speed cameras to be used for the Automated Work Zone Speed Enforcement program. These enforcement zones are clearly marked with signs informing motorists of the use of photo enforcement while active.

4. Director's Report

HOCTC Director, Dana Crisino gave a synopsis of HOCTC activities for the past quarter.

 PEL – I-90 Exit 31 Study – The first round of stakeholder and technical advisory meetings happened in January and these are continuing. The consultants are working towards data analysis and working with NYSTA, NYSDOT, and FHWA to coordinate the timing of projects happening in the surrounding corridors.

- The public engagement portion of this study will be starting shortly, so members of the GP&L will be contacted.
- This is a 22-month study.
- Safe Streets and Roads for All (SS4A) Grant The kickoff meeting took place in January for the two-county Safety Action Plan. This study will be complete by the end of 2024. The public engagement portion of the plan will take place in March, April and May. This study is on local roadways only and will look at crash data to identify issues and develop strategies to apply for the implementation portion of this grant. Once this study is complete and approved, it will allow any municipality within the two counties to apply for implementation funding.
- O Long Range Transportation Plan (LRTP) and the Human Services Transportation Plan (HSTP) are also on short timeframes for updates, being due at the end of 2024. These plans are required for funding for the MPO. The 20-year plan is updated every five years. The HSTP is an individual plan but will be worked into the LRTP and deals with public transit funds. The HSTP deals with the needs of the elderly and disabled population that may require assistance. The HSTP is also updated every five years.
 - At the September meeting, HOCTC will present draft content then that draft will go out for public comment and review in October. This will need to be approved by the GP&L at the December meeting.
- O What is an MPO? Each director's report will contain a handful of slides on what MPOs are and what they do. This was brought up in the December GP&L Meeting and will be carried through throughout the year for new attendees and as a refresher for everyone else.
- o MPO's were formed in 1962 under the Federal-Aid Highway Act. In 1962, areas with a population greater than 50,000 were mandated to establish a "Three C" planning process for federal-aid transportation projects. HOCTC is an original MPO for the country, formed in 1963, even though it is a small urban area, it has always been an established urban area.
- o In 1973, the Federal-Aid Highway Act dedicated funding to planning activities and formalized the process, organization, and procedures. The planning and policy committees were devised to show how the money would benefit the regional population by identifying issues that impact the area.
- O The MPO and the Herkimer Oneida Counties Comprehensive Planning Program (HOCCPP) was also formed to act as the regional planning board or commission but with no official authority as a planning board. HOCCPP can identify a regional planning project where funding can be used such as housing and transit initiatives through reciprocal planning services between Herkimer and Oneida Counties. HOCCPP acts as the balance if a project is not transportation related.
- Current support to Herkimer County through the Oneida County Planning Department includes transportation planning, DSS support, general human service planning, and census and mapping support.
- O Bylaws for the GP&L were updated a few years ago when membership was changed for the first time since 1973.
- o The "Three C" process is continuing, cooperative, and comprehensive planning based on the transportation network. Major programs carried out through the MPO include a 20-year vision, the 4–5-year capital program, the TIP, which identifies projects from

- the two counties of six in DOT's region 2, and the annual work program (UPWP) to show what HOCTC staff is doing for program delivery in the two counties.
- The Public Participation Plan (PPP) is the newest requirement for all MPOs to have a published plan that dictates how the MPO is talking to the public to ensure inclusivity and equity. This is a very evolving field.
- Obligated projects have to be posted on the website every year. MPOs are to be a public forum for communities and agencies to bring questions to a larger body to make regional decisions as to how transportation planning funds are being spent.
- The current federal legislation is the IIJA/BIL. This will eventually change so priorities will likely shift as legislation changes. MPO funding can only be used for planning, not capital projects. MPOs are to use the Federal Highway Administration allocation for planning to conduct technical studies, look at the larger vision, and work with partners to figure out opportunities and limitations within the region.
- HOCTC is designated an MPO by the governor. The 14 MPOs in NYS are based on population and federal lane miles, so the funding allocation is split between 14 MPOs. The newest MPO was devised due to the expansion of the Fort Drum population with more permanent assignments there.
- There are three committees for HOCTC:
 - The Transportation Planning Committee (TPC) is an advisory subcommittee that reviews issues before going to the Policy Committee or the Governmental Policy and Liaison Committee (GP&L) for final review and decision.
 - The Transportation Coordination Committee (TCC) handles the human services aspect of transportation and is a subcommittee of the TPC. They may share information with the TPC.
 - The GP&L acts in an executive capacity. It is a 19-member board made up of elected or appointed positions between the two counties, with 80% membership being Oneida County and 20% membership being Herkimer County. There is representation from the transit authority, human services agencies, and the economic development sector.

5. NYSDOT Region 2 Report

Mark DeRocco reported on the activities that NYSDOT Region 2 has performed in the last quarter.

- Federal Grant Opportunity for transportation infrastructure is available. The Northern Borders Regional Commission Catalyst Program (NBRC).
 - The deadline for the pre-application is March 15, 2024 and the grant requires a 20% match.
- Bridge NY Round 5 Region 2 has 14 bridge applications submitted totaling \$13.8M and 18 culvert applications totaling \$8.8M.
 - These applications are under a review process with a mid-2024 award announcement expected.
- Local investment for SFY 2023/2024 was \$65.7M with CHIPS being the highest investment by far. There was also investment in extreme weather recovery, PAVE, Pave our Potholes, and State Touring Route.
- o Infrastructure investment was for \$28.5M with investments in safety, bridges, bike/pedestrian, local bridges and pavement. This is the capital program

- funding the Boonville Safety Project on Routes 12 and 12D, the N. Genesee St. Safety Project that will be let in March 2024, the W. Main St. bridge over Moyer Creek and other jobs in Western Oneida County.
- The City of Little Falls applied for funding for the Salada Bridge but the project doesn't really fit into the Bridge NY parameters since it is not well traveled. A question was asked about other potential funding sources. It will be looked into.
- A question was asked about the timing of awards for the Wood Creek Bridge in New London. It's a dead-end road with a bridge on the other side as well, Locke Rd. The selections will be in April. The application should reflect that this is on a dead-end road with the only access to a lock for more leverage.

6. New York State Thruway Authority Report

Dana Crisino for Jerrin George, NYSTA Assistant Engineer, gave a synopsis of NYSTA activities for the past quarter.

- O Dana explained that NYSTA had a conflict with the Syracuse MPO meeting where there will be a discussion about the I-81 project.
- o There was a brief discussion on the mile marker posts and how I-81 will only have mile interval posts.
- o Tentative 2024 Projects:
 - MP197.9 to 2010.3 Pavement resurfacing Letting 1st quarter of 2024, completion in Winter 2024, which is new due to need.
 - MP227.40 Mainline bridge rehabs over Sterling Creek Letting 1st quarter of 2024, completion in Winter of 2025.
 - MP219.91 Replacement of Thruway Bridge over Mohawk St. (Route 28) Letting 3rd quarter 2024, completion Winter 2026.
 - There was a discussion about how the traffic pattern would change if the bridge was closing and traffic was being rerouted. DOT stated that no road closures will take place for this project but that NYSTA is not opposed to closing I-90 since it is such a long replacement project.
 - MP 238.22 Thruway bridge replacement over Oriskany Blvd. (Rt 69) Letting 3rd Quarter 2024, completion Winter 2026.
- o Tentative 2025 Projects:
 - Rehab of MP233.27 N. Genesee St. Bridge (away bridge) Letting 1st Qtr. 2025
 - o HOCTC will be working with NYSTA on the PEL Study since they do not want to rip apart the bridge before the study is complete.
 - MP257.09 Replacement of Rt. 46 Bridge over Thruway Letting 3rd Quarter 2025, depending on when the other bridges are complete.
 - MP197.9 to 210.3 Safety upgrades Letting 1st Ouarter 2025.
- o The Oneida Service Area opened recently.

- HOCTC Resolution 2024-01: Approval of the 2024 Public Participation Plan (PPP) Presenter: Julie Richmond, HOCTC
 - o As mentioned in the MPO 101 discussion, MPOs exist to address transportation-related issues and to plan for and make use of federal transportation funds.
 - As a requirement to receive federal funds, HOCTC must maintain the three C process, and to continue to be eligible for these funds that process must be documented and directed by current federal transportation legislation.
 - O The purpose of the PPP is to serve as the MPO's primary approach to shaping public engagement by describing the methods, means, and formats to provide the opportunity for public input. It must also define which populations should be included in the process. It then must ensure that all citizens have reasonable, equitable, and accessible means to participate.
 - o This plan is being updated in alignment with updates to the LRTP and HSTP and the initiation of the PEL Study and the SS4A grant.
 - This document was released for a 45-day public review upon its completion in December 2023. The review yielded comments on evaluation metrics and Virtual Public Input Tools.
 - Revisions included additional evaluation metrics, reorganized content, the use of tables to link goals and objectives with metrics, providing the schedules for the MPO Planning Products, and all revised outreach strategies along with virtual engagement strategies, presented in a toolbox format.
 - The new document provides a well-defined process that serves as a guidebook for either HOCTC staff or a public engagement consulting firm to achieve the goals of the HOCTC public engagement process.
 - Discussion: None

- HOCTC Resolution 2024 02: Approval of the 2024 2025 Unified Planning Work Program (UPWP) - Presentation, discussion, and request to approve the 2024-25 UPWP. Presenter: Julie Richmond, HOCTC
 - This plan is effective April 1, 2024 March 31, 2025. The UPWP identifies planning activities such as transportation planning studies and technical analysis, as well as administrative and support functions proposed for funding received in an annual allocation.
 - O Think of the UPWP as the short-term planning, the TIP as the medium-range planning and the LRTP as the long-range planning. These plans cover all modes of surface transportation.
 - The framework for the UPWP is derived from goals listed in the LRTP that are built around the two county goals for the provision of mobility, accessibility, safety, economic vitality, and the preservation, maintenance, and resiliency of

- the existing transportation network. The long-term goals feed into the short-range planning of preliminary planning, data collection and analysis.
- The work that HOCTC staff do to administer the two-county shared vision for the transportation network ensures that the mobility provided reaches everyone sustainably and equitably. This is accomplished through public engagement efforts.
- o The UPWP must also match up with national planning emphasis areas specified by federal regulations: Climate reducing environmental impacts and building a resilient transportation system, Equity/Justice 40 data-driven support monitoring by HOCTC staff, Complete Streets Safe Streets for All Safety Action Plan, STRAHNET Strategic Highway Network for the use of roads for emergency mobilization and movement of heavy equipment to support US Military Operations, Other Agency Coordination HOCTC is required to coordinate with all the federal land management agencies. This process must be interwoven throughout the UPWP environmental planning activities. Planning and Environmental Linkages Interstate 90 Exit 31 PEL Study, Transportation Planning Data data-driven analysis completed with every task.
- The Work Plan is structured into Task Categories that align with and reflect the requirements of national planning objectives and LRTP goals. The categories represent Program Support and Administration, General Development and Comprehensive Planning categories, TIP Maintenance, and completion of the individual planning projects that develop and maintain the four core documents. These are the highest priority of HOCTC's planning process and how the funding is distributed throughout the UPWP.
- The major activities included in the 2024-2025 UPWP include updating HOCTC's Long Range Transportation Plan and Human Services Transportation Plan, continuing support of the 2023-2027 TIP, Exit 31 PEL Study, Safe Streets for All grant, and public engagement for these initiatives.
- o This UPWP identifies \$1.1M in federal and non-federal funding for these efforts. Part of this is the contractual work to complete the PEL Study and the LRTP/HSTP update.

Bylaws of the Governmental Policy and Liaison Committee

WHEREAS, it is desirable for the Governmental Policy and Liaison Committee of the Herkimer-Oneida Counties Transportation Council and the Herkimer-Oneida Counties Comprehensive Planning Program to be governed by rules for the efficient and proper administration of their affairs.

THEREFORE, BE IT RESOLVED, that the following Bylaws are hereby adopted by the Governmental Policy and Liaison Committee.

Article I

Section 1 Meeting:

Meetings of the Governmental Policy and Liaison Committee shall be held at least quarterly, per the standard calendar year beginning on January 1. The meetings may be called by any officer of the Committee, only. Written notice thereof shall be either mailed or emailed to every member of the body, at least one week prior to the scheduled meeting. Meetings of the Committee shall be duly conducted in agreement with the Herkimer-Oneida Counties Transportation Council Public Participation Policy. The Public Participation Policy shall govern requirements for scheduling, moving, or cancelling meetings.

Section 2 Quorum:

At any meeting of the Committee, a quorum shall consist of a majority of the voting members or their officially designated representative. The Chairperson or Vice-Chairperson may designate, at the time of the meeting, a designee from the attendees present, to represent a voting member such that a quorum can be obtained; provided sufficient justification can be made to the Committee Officers that qualifies the designee to represent the absent member. No action shall be taken in the absence of a quorum, except that another meeting can be called for a subsequent date.

Section 3 Voting:

At all meetings of the Committee, each voting member shall be entitled to cast one vote. A majority vote shall be necessary for the adoption or approval of any proposed action, resolution, or other voting matter.

Each voting member may officially designate a representative to attend the meeting and vote on their behalf. The utilization of a designated representative must be communicated to the Secretary or Clerk prior to the meeting being called to order. During roll call, the designated representative will answer in the affirmative and identify which

voting member they are representing.

Section 4 Proceedings:

At any meeting of the Committee, the following shall be the general order of business:

- Approval of the Minutes
 - Public Comment
- Director's Report
- NYSDOT Region 2 Report
 - Other Reports
- Presentations
 - Old Business
- New Business
- Adjournment

All meetings of the Committee shall be conducted in accordance with Robert's Rules of Order.

Section 5 Rules of Procedure:

All meetings of the Committee shall be open to the general public and allow for public comment at the designated agenda item. Public comments may be received on any agenda item of the same meeting date. Public comment may be provided in written form when received by the Clerk or Secretary by 3:00 p.m. the day preceding the scheduled meeting.

Section 6 Membership

A. Voting Members.

The Governmental Policy and Liaison Committee shall be comprised of nineteen (19) voting members as follows:

Chairman, Highways Committee, Herkimer County Legislature

Mayor, City of Utica

Herkimer County Town Supervisor or Village Mayor (max 1 position)
Chairman, Central New York Regional Transportation Authority
Regional Director, New York State Department of Transportation
Chair, New York State Thruway Authority Board of Directors
Executive Director, Herkimer County Industrial Development Agency

The selection of each representative is at the discretion of the signory organizations, where not specified by position. Each member shall be eligible to service during the term as long as the member occupies the position held at the time of selection.

B. Officers:

The officers shall be a Chairperson, a Vice-Chairperson, a Secretary, and a Clerk.

The Chairperson and Vice-Chairperson shall serve in two-year terms and rotate between the chief elected official of Herkimer and Oneida Counties. Leadership will change with the even- numbered years.

The Secretary shall be the Herkimer-Oneida Counties Comprehensive Planning Program Director.

The Clerk shall be the Director of the Herkimer-Oneida Counties Transportation Council or in absence of a director, the Transportation Program Manager of the Herkimer-Oneida Counties Transportation Council will serve in this capacity.

C. Vacancies/Replacement Procedure

If a voting member becomes ineligible or unable to serve, a new member named by the chief elected official or head and/or board of the appropriate governmental unit shall be allowed to nominate a replacement within 30 days of the vacancy and request that nominee be brought to the next full policy committee meeting to be voted on and officially appointed to the committee.

Section 7 Duties of Officers:

- A. The Chairperson, shall be charged with the following duties:
 - 1) To preside at meetings.
 - 2) To call meetings in accordance with these Bylaws.

- 3) To sign, with the Secretary, documents of the Committee in accordance with official actions taken.
- 4) To request HOCTC staff to prepare information on relevant planning topics.
- 5) To carry-out, any additional duties, as assigned by the Committee.
- B. The Vice-Chairperson, shall be charged with the following duties:
 - 1) To serve and conduct all duties of the Chairperson in their absence.
 - 2) To carry-out, any additional duties, as assigned by the Committee.
- C. The Secretary, shall be charged with the following duties:
 - 1) To ensure meetings of the Committee function in accordance with these Bylaws.
 - 2) To ensure all actions taken are recorded properly.
 - 3) To duly sign assurances of correct actions of the Committee.
- D. The Clerk, shall be charged with the following duties:
 - 1) To keep the minutes of the meetings of the Committee.
 - 2) To be a custodian of the records of the Committee.
 - 3) To ensure proper correspondence of all communications of the Committee.
 - 4) To prepare all meeting materials for each agenda of the Committee.

Article II

Section 1 Enactment:

- A. These Bylaws may be amended by the majority of the voting members present at any meeting of the Committee. Amendments to these Bylaws shall be made by resolution and considered to be effective as of the close of the same meeting, or by a date otherwise stipulated in the resolution.
- B. The amended Bylaws and copy of the approving resolution shall be provided to every voting member prior to the next scheduled meeting of the Committee.







An Amendment, in the form of an Administrative Modification (Admin. Mod.) is made to the Transportation Improvement Program (TIP) when revisions of cost changes of \$549,999 or less, an increase in the total cost of the project is less than 10% or when there is a change in funding year for any phase of an existing PIN project. An Admin. Mod., as per HOCTC TIP procedures, require approval from the NYSDOT Region 2 RPPM and the HOCTC Program Manager. Joint approval is issued in the form of a jointly signed letter, which is addressed to the NYSDOT Region 2 Director, notifying them of the Admin.
