Oneida County Office for the Aging Month Outreach Site Visits

Oneida County Office for the Aging/Continuing Care provides information and assistance through its long-standing community outreach monthly site visit schedule. This schedule is an established time where a case manager or other OFA/OCC representative visits community locations in several areas of the county. This is ideal for those needing to speak with a case manager, but not necessarily in need of an in-person home visit.

OFA/OCC site visits provide an opportunity for older adults, caregivers and family members to meet with a case manager or department representative for one-on-one meetings and educational presentations at convenient locations across Oneida County on a monthly basis. Many of the of the locations include senior centers, senior housing complexes, nutrition program congregate dining sites and other community-based settings where older adults and their families frequently gather.

OFA/OCC provides information assistance, screening, assessments and referrals for all needs relating aging services and long-term care supports by appointment-based home visits for those considered homebound, and unable to visit an outreach location due to a disability. The monthly site visit schedule allows for convenient access to OFA/OCC staff, and is particularly helpful for those needing information and assistance for benefit and entitlement counseling and other types of information, but not necessarily needing a home visit.
