The November 2018 meeting of the Oneida County Fire Advisory was called to order at 7:00 PM on November 19th. Chairman Eaton led the pledge.


Mandryck read the minutes of the October 22, 2018 meeting. There were no revisions suggested. Brement made a motion to accept the minutes and Glenn seconded. The minutes were approved by the board.

The following topics were then discussed:

1. Emergency Services
  - a. Radio status: Nothing new to report
  - b. Grants: No announcements of recipients or amounts yet.
  - c. The previously distribute survey has seen poor responses. While 100% of fire coordinators have responded, Only 700 of the 1700 chiefs and 5900 of the 80,000 volunteers have responded. FASNY will hold a December 8<sup>th</sup> meeting to discuss the results.
  - d. The Fire Officer 1 class is being broken up into 5 modules plus the 63 hour class.
2. Legislators
  - a. The 2019 budget has been passed..
3. Fire Prevention
  - a. A grant for \$18,000 will be used to purchase additional blow up houses.
4. Expo
  - a. The Expo will be moving back to MVCC. Dates being looked at are May 17<sup>th</sup> and 31<sup>st</sup>..
5. Fire Police
  - a. There has been a request to allow fire police to carry concealed weapons. This will require a 40 hr coarse and carriers would need to qualify each year.
6. Radio Committee
  - a. A meeting was held November 14<sup>th</sup> to discuss channel lineups and the "May Day" policy. The next meeting is scheduled for December 12<sup>th</sup> at 7 PM at DPW.
7. EMS (No Report)

- a. Ambulance meeting set for December 5<sup>th</sup> at 7PM at DPW.
- 8. Cause and Origin (No Report)
  - a. Waiting to hear on new members.
- 9. Volunteers Association
  - a. Meeting held November 15<sup>th</sup>. Need to identify two new members to the OCFAB.
  - b. The fund raiser in January will be a winter softball tournament. Raffle tickets and flyers have been distributed to departments.
  - c. There was a rumor that box alarms were going away. Revere stated that it is not true and that the county encourages more use of them.

  - a. The FAB is subject to the county's ethics policy. As a result, members will be required to complete the county's ethics form.
