The September 2019 meeting of the Oneida County Fire Advisory was called to order at 7:00 PM on September 16, 2019. Chairman Eaton led the pledge.


Mandryck read the minutes from the June 2019 meeting. There were no corrections offered. A motion to accept the minutes was made by Deking and seconded by Furgol. The minutes were approved by the board.

The following topics were then discussed:

1. Emergency Services
 - a. Radio testing continues, including testing by law enforcement.
 - b. The complete changeover to the new system has not yet been scheduled.
 - c. Funding for the Verona and Boonville towers is in place. Funding for the Floyd and Annsville towers is pending.
 - d. An email is now being sent out via the cadd system. The fax server has been shut off.
 - e. Training requests were approved as submitted.
 - f. Deking asked if it was true that box alarms cannot occur with out of county departments. Lampman stated that this was not true.
2. Legislators
 - a. Flisnik noted that the Capital plan has \$2.4M for the remaining towers.
 - b. New state laws on discovery require documents be turned over to defense attorneys within 15 days, putting a burden on local staff. Lampman is currently handling this, spending 30 to 40 minutes per case. The county is working on giving the District Attorney's office direct access to 911 data. Clancy noted that all traffic tickets fall under this requirement.

 - a. Next Expo scheduled for May 29, 2020.

 - a. The next meeting will be held October 21, 2019 at 7 PM at DPW.















